# 2022 Glen Eira Leisure (GEL) Attend & Win Competition – Terms and Conditions

The promotion is a game of chance. By entering the promotion, you agree to be bound by the following terms and conditions:

# Eligibility

- 2. To be eligible to enter the promotion, an entrant must:
  - a. be an active member of Glen Eira Leisure (GEL) throughout the period of the promotion;
  - b. attend GESAC 15 times or more in the promotion period (Sunday 1 May to Tuesday 31 May, inclusive)
  - c. agree to provide evidence of eligibility to enter the promotion if selected as a Prize Winner.

## Prize draws

- There will be one (1) draw on the date set for completion of the promotion (Wednesday 1 June). There will be
  - 1<sup>st</sup> Prize (3 month GEL membership credit equivalent to the winner's current membership),
  - 2<sup>nd</sup> Prize 2 month GEL membership credit equivalent to the winner's current membership),
  - 3<sup>rd</sup> Prize (1 month GEL membership credit equivalent to the winner's current membership)
- 8. The Prize draws will be conducted by GEL.
- 9. GEL will select the winner of each Prize draw (Prize Winner).
- 10. GEL's decision is final, and no further correspondence will be entered into.

## Notification

- 11. Within two (2) business days of each Prize draw, GEL will notify the Prize Winner by:
  - a. email, at the email registered with GEL; and
  - b. telephone, at the telephone number registered with GEL.
- 12. GEL reserves the right, at any time, before awarding a Prize to verify the validity of entries by requesting:
  - a. proof that during the promotion period, the Prize Winner was an active member of GEL;
  - b. proof of age of the Prize Winner; and
  - c. proof of identification of the Prize Winner

- 13. If a Prize Winner:
  - a. responds within seven (7) business days of the notification under clause 11, they will be deemed to have accepted their option to select a Prize (Winner's Acceptance); or
  - b. fails to respond within seven (7) business days of the notification under clause 11, they will automatically forfeit their option to select a Prize, and a new Prize Winner may be selected.
- 14. If the Prize Winner is unable to prove their eligibility within seven (7) business days after being notified by Council under clause 11, they will automatically forfeit their option to select a Prize, and a new Prize Winner may be selected.
