

## **Glen Eira Leisure Slide Name Competition**

### **Terms and Conditions**

This competition ('Competition') is run by Glen Eira City Council ('Council') to promote Glen Eira Leisure ('GEL') by engaging with its members and other GEL patrons. Entrants are asked to suggest a name for the green water slide at Glen Eira Swimming and Aquatic Centre ('GESAC'). The Competition winner will be the entrant who comes up with the most original, appropriate and creative name.

1. By entering the Competition, entrants accept these terms and conditions of entry ('Conditions').
2. Entry is open only to residents of Victoria. Councillors and employees of Council (and their immediate family members) are not eligible to enter.
3. This is a competition of skill.
4. The Competition commences 4:00pm on 29/09/2021 and ends 11:59pm 13/10/2021.
5. To enter the Competition:
  - (a) The entrant must complete all requested areas on the entry form located at <https://www.geleisure.com.au/swim/slide-name-competition> including providing a suggested name for the water slide and providing the reason for choosing the name (in 25 words or less);
  - (b) The entry must be submitted online
  - (b) The entry must be submitted by 11:59 pm on 13/10/2021.
6. Multiple entries are permitted provided that a different name is suggested in each entry.
7. The suggested name:
  - (a) Must comply with [Council's values](#) ;
  - (b) Must not contain any offensive or inappropriate language;
  - (c) Must be original and not infringe the intellectual property rights of any other person.
8. Entries will be judged by a panel of three GEL staff members on 14/10/2021. Winners will be chosen on the basis of originality and creativity at the judging panel's discretion. Where multiple entries suggest the winning name, the Judging Panel will choose a winner based on the reason provided for choosing the name. The Judging Panel decision is final, and no further correspondence will be entered regarding the Judging Panel's decision.
9. The winning name suggestion will become the name of the green slide at GESAC, as indicated through permanent signage in the aquatic area of GESAC. The winning entrants name will not be present on this signage.

10. The winner will receive a prize of 3-month membership to GESAC or 3-month credit on their existing membership unless the winner is under 14 years of age. If the winner is under 14 years of age they will receive a prize pack to the equivalent value.
11. There will be 5 runner up prizes of \$20 T&P at GESAC vouchers.
12. The prizes are not transferrable, exchangeable or redeemable for cash and Council is not liable for any loss (including but not limited to any damage, claim, injury, cost or expense), which is suffered or incurred by any person in connection with redemption or use of any of the prizes.
13. Winners must be able to collect prize in person from GESAC at 200 East Boundary Road, Bentleigh East, VIC, 3165 by 30 June 2022 or at a later date as agreed by Council at its sole discretion.
14. Winners will be notified via email within one week of the Judging Panel making a decision.
15. The winning slide name will be announced via Glen Eira Leisure's Facebook page and Instagram after confirmation of major prize acceptance.
16. Upon Submission of an entry the proposed slide names contained within the entry will become and remain the Property of Council. By entering the Competition the entrant assigns Council all rights, including intellectual property rights in the proposed slide name. Entrants consent to Council (or any third party on behalf of Council) dealing with the proposed slide name in any way which may infringe the moral rights of the entrant (including not attributing the entrant as the creator of the slide name, and modifying or adapting the slide name).
