

GELSS Fun Day – Terms & Conditions

These Terms and Conditions apply to all attendees, participants, parents, guardians, and visitors attending the GELSS Fun Day on Saturday 3 October 2026. The event is a Swim School retention and community engagement day, with free entry for registered attendees, subject to confirmed capacity limits and any venue or operational requirements. By registering for, attending or participating in the event, you agree to follow these Terms and Conditions and any reasonable directions given by GEL staff.

1. Promoter

The event is organised by Glen Eira Leisure Swim School (GELSS), operated by Glen Eira Leisure (GEL) on behalf of Glen Eira City Council (GECC), unless otherwise advised.

2. Promotion Overview

- The GELSS Fun Day is intended to be a safe, inclusive and family-friendly community event celebrating the end of Term 3.
- Planned activities include live music, fairy floss, balloon animals, the inflatable, waterslides, swim races, pool games and a scavenger hunt.

3. Event Participation

- Participation in activities is voluntary and attendees should only take part in activities that are suitable for their age, health, swimming ability, confidence level and supervision arrangements.
- Event organisers may refuse participation in an activity where they reasonably believe there is a safety risk or the participant is not following instructions.

4. Registration and Attendance

- Entry is free for registered attendees.
- Only one parent or guardian needs to register for free entry for the family.
- The parent or guardian must show the email receipt to prove registration for free entry.
- Where registration is required, attendees must provide accurate and complete information, including any details needed to manage participation, safety, capacity and communications.
- Parents or guardians must register on behalf of children where required.
- External visitors, including new or returning members, must complete the registration form to obtain free entry.
- Entry may be limited due to venue capacity, safety requirements, weather conditions, or operational needs.

5. Eligibility for Activities

- Swim races are available to current GELSS members in Level 7 and above only and will be held in the outdoor 50 metre pool.
- External visitors are not eligible to participate in swimming races.
- Pool games are open to all registered attendees, subject to age, safety, capacity, supervision and pool availability requirements.
- Attendees must follow any activity-specific instructions, including pool rules, safety signage and directions from GEL staff or activity supervisors.

6. Health & Safety Risk

7. Photography, Filming & Media

- Photography or filming may occur during the GELSS Fun Day for event records, promotional materials, social media or community updates.
- By attending the event, attendees acknowledge that they may appear in photos or video footage taken at the event.
- If an attendee does not wish to be photographed or filmed, they should notify event organisers before or on arrival at the event.

8. Privacy

Personal information collected for the GELSS Fun Day will be used for event registration, communication, capacity management, safety, administration, promotional planning, prize fulfilment and related event purposes. This may include information collected through registration links, QR codes, entry forms or activity participation records used for the event. Information will be handled in accordance with Glen Eira City Council's Privacy Policy and applicable privacy laws, and will not be shared except where required for event operations, safety, legal compliance, prize administration or with consent.

9. Scavenger Hunt

All attendees are eligible for the scavenger hunt.

10. Prize Draw

- One (1) winner will be drawn during the week of October 5, 2026.
- The winner will receive:
 - One (1) Month Free on their Swim School Membership Credit

- Winners will be contacted using the details on their registration.
- If a winner cannot be contacted within 14 days, Glen Eira Leisure reserves the right to redraw the prize.

11. Prize Conditions

- Prizes are non-transferable and cannot be redeemed for cash or exchanged for any other product or service.
- GEL may verify entries, eligibility and prize claims and may disqualify any entry that is incomplete, late, duplicated, false, misleading, unsafe or inconsistent with these Terms and Conditions.

12. Two-Week Free Offer

- Eligible new or returning members may claim two weeks free swimming lessons if they sign up during the period Saturday 26 September – Saturday 03 October.

13. Two-Week Free Offer Conditions

- The two weeks free swimming lessons offer is subject to availability, enrolment requirements, class suitability, program terms and any additional conditions communicated by GEL.
- Any signups outside of these dates will not receive the two-week free offer.
- The offer cannot be exchanged for cash, transferred to another person.

14. General Conditions

- Council reserves the right to verify attendance and eligibility.
- Council may amend, suspend or cancel the promotion if required.
- Fraudulent participation may result in disqualification.
